Changes are in testcases doc & in the artifacts (ZIP)

Dave describes the issue

- caused by the presence of Java code in the test suite
- need to describe how an SCA runtime is compliant even if it does not support Java implementation type
- a) removed much Java
- b) reuse artifacts from Assembly test suite
- c) Leaves a few Java artifacts these test @OneWay
- need to get a description of these few artifacts into the test suite adaptation documentation
